## OFFICIAL RULES

**By participating, you (“entrant” or “you”) agree to abide by and be bound by these Official Rules and the decisions of Sponsor, which are final and binding in all respects and not subject to appeal.**

**1. CONTEST PERIOD:** The Lifeway Foods The San Diego Gluten Free & Allergen Friendly Expo Ticket Giveaway Sweepstakes (the “Sweepstakes”), is a random draw sweepstakes. The Sweepstakes begins at 2:30:00 p.m. Central Time (CT) on February 1, 2017 and ends at 5:30:00 p.m. CT on February 8, 2017 (the “Sweepstakes Period”). The sole determinant of time for the purposes of receipt of a valid entry in the Sweepstakes will be Sponsor’s clock. The Sweepstakes will consist of five (5) randomly selected winners chosen once the sweepstakes has ended (on or after August 16, 2016).

**2. ELIGIBILITY:** The Sweepstakes is open only to persons ages eighteen (18) and older, who are, as of the time of entry, legal residents of, and physically located within the Continental United States (collectively, “Territory”), and are not officers, directors, or employees of Sponsor, their respective parent, subsidiary or affiliated companies; or the advertising, promotional or fulfillment agencies of any of them (collectively, the “Sweepstakes Entities”); nor members of their households or immediate families (defined as parents, children, siblings, step-parents, step-children, step-siblings and their spouses). The Sweepstakes is subject to all applicable federal, state, and local laws.

**3. HOW TO ENTER:** Internet access required. To enter, visit [www.lifewaykefir.com/ticket-giveaway-san-diego-gluten-free-allergen-friendly-expo](http://www.lifewaykefir.com/ticket-giveaway-san-diego-gluten-free-allergen-friendly-expo), leave a comment answering the proposed prompt (“Your favorite Lifeway Kefir and gluten free pairing”), and click the “Submit Comment” button during the Sweepstakes Period to receive one (1) entry in the Sweepstakes for an opportunity to win a prize. All required fields must be completed or your entry will not be eligible. All entries for the Entry Period must be received by 5:29:59 p.m. CT on the last day of the Entry Period. You may only enter through the website, from a computer or mobile device. All entries become property of Sponsor and will not be returned. There is a limit of one (1) entry per person. If a dispute arises regarding who submitted an entry, the entry will be deemed to be submitted by the authorized account holder of the email address provided at time of entry. Authorized account holder is defined as the natural person who is assigned to

an email address by an Internet access provider, online service provider, or other organization responsible for assigning email addresses for the domain associated with the submitted email address.

**4. LIMITATIONS:** Entrants who have not complied with these Official Rules are subject to disqualification and their entries will be void. Sponsor reserves the right to disqualify any entrant's registration in the Sweepstakes if Sponsor determines or suspects that the entrant has attempted to undermine the legitimate operation of the Sweepstakes by cheating, hacking, deception, or other fraudulent, deceptive, or unfair playing practices. Entrants must submit images that are appropriate for the Sweepstakes theme. No images featuring nudity, illegal drugs, alcohol or crude behavior of any kind allowed. Sponsor reserves the right to cancel, modify, or suspend the Sweepstakes at any time if fraud, technical failures, or any other errors or other causes corrupt the administration, security, integrity, or proper play of the Sweepstakes. In the event of cancellation, Sponsor reserves the right to select the winners from among all eligible entries received up to the time of such cancellation, in a manner determined by Sponsor to be fair, appropriate, and consistent with these Official Rules.

The Sweepstakes Entities do not warrant that access to the Sweepstakes will be uninterrupted. Neither the Sweepstakes Entities, nor any of their officers, directors, shareholders, employees, agents or representatives (individually and collectively, "Releasees") are responsible for: (a) entries from persons residing, or physically located, outside the Territory; (b) entries that are altered, delayed, deleted, destroyed, forged, fraudulent, improperly accessed, inaccurate, incomplete, interrupted, irregular in any way, late, lost, misrouted, multiple, non-delivered, stolen, tampered with, unauthorized, unintelligible or otherwise not in compliance with these Official Rules; (c) lost, interrupted or unavailable networks, servers, satellites, websites, or other connection, availability, or accessibility problems arising in connection with or over the course of the Sweepstakes; (d) failure of personal computers and/or software and hardware configurations, any technical malfunctions, failures, or difficulties, printing errors, clerical, typographical or other errors in connection with the administration of the Sweepstakes, the processing of mail or entries, or the offering or announcement of the prizes or in any prize notification documents; (e) any other errors of any kind relating to or in connection with the Sweepstakes, whether human, mechanical, clerical, electronic, or technical in nature; (f) the incorrect or inaccurate capture of information, or the failure to capture any information in connection with the Sweepstakes; or (g) damage to a user's system occasioned by participation in this Sweepstakes or downloading any information necessary to participate in this Sweepstakes; even if caused by the negligence of any of the Releasees.

**5. PRIZES AND APPROXIMATE RETAIL VALUE ("ARV"):** Five (5) prizes will be awarded. Five winners will receive a ticket code for a free ticket emailed to the entrant. ARV of each prize: \$15. Total ARV of all prizes: \$75.

All federal, state, and local taxes (including income and withholding taxes), if any, as well as any other costs and expenses associated with prize acceptance not specifically mentioned herein are not included and are solely a winner's responsibility. If the actual value of a prize is less than the stated

ARV in these Official Rules or in any Sweepstakes-related correspondence or materials, the difference will not be awarded. Any depiction of a prize is for illustrative purposes only and may not reflect actual prize won. Prizes are not redeemable for cash or transferable, and must be accepted as awarded. PROCEDURES AND ODDS OF WINNING:** On or about the dates listed in Section 1 above (the "Contest Period"), in a random drawing, Sponsor will select the potential prize winners for the Entry Period from among all those eligible entries received during the Entry Period. Odds of winning a prize depend on the total number of eligible entries received during the Entry Period.

**7. HOW TO CLAIM YOUR PRIZE:** All potential winners are subject to verification and participant's full compliance with these Official Rules before any prize will be awarded. On or within two (2) business days following the Drawing Date, the potential winners for the Entry Period will be notified via email to obtain contact information to verify eligibility as well as any additional required information or responses. It is the responsibility of the winners to claim their prizes with a response to our initial email. Sponsor is not responsible for prizes not claimed and will not provide alternate prizes of winners fail to claim their prizes.
